

Here is list 4 technologies that every accounting firm should have in place.

- Appointment setting solutions If your firm is still calling, e-mailing, or sending postcard reminders to setup tax appointments, you need this solution now. These solutions allow your clients access to the company or individual preparer's schedule to book a predetermined block of time to discuss their taxes. This solution eliminates all the back and forth that goes along with scheduling and allows the accounting firm to allow booking far in advance and even incentivize clients to book their appointments early.
- File/Date Portals Every accounting firm should be using a file portal either provided by your Tax software or a third party such as Citrix ShareFile. This solution is not only necessary for the secure upload and download of documents, but it gives your clients a place to retrieve their returns without having to bog down your administrative staff with these requests.
- Modern Communication tools This is a broader range of technologies but using modern communication tools is critical to not only interface with the younger generation but also to provide some resiliency in your infrastructure. Using a modern VOIP platform will allow your clients to text a company phone number (not your personal cell phone), enable all staff members to answer their work extension through an app on their cell phone, and allow inter-office chat capability.
- Multiple Monitors To the users that have never used multiple screens, they often view it as excessive but users that have experienced the benefits often can't live without them. Multiple monitors maximize productivity by allowing users to view different applications at the same time in full screen such as viewing client documents and entering data into your tax software

Many firms have seen the recent cyber security headlines or were given a 10-page questionnaire when they went to renew/order cyber insurance. One thing is for certain, and that is you can't hide anymore. More and more of the public is aware of cyber security protocols and the number of cyber attacks are growing daily, so putting your head in the sand is no longer an option. Here are some technologies you must have in place to truly be secure.

2FA/MFA - No one likes these solutions, but they do a great job at securing your accounts and should be used on every account you have.

Professional email - You can't use a carrier provided (Comcast, Verizon, AOL, or Yahoo) account for your business communication. Not only does it look unprofessional, but it is! The security on these accounts is very simplistic and you can't verify any type of compliance using these accounts.

Cybersecurity Awareness Training – Most cyber insurance companies require that you have at least an annual training completed by your staff. GINGER & PEAR BOURBRON SPLASH

This Linger Pear Bourbon Cocktail is a perfect way to celebrate early fall! It's fruity and slightly sweet with notes of warm ginger and a generous splash of smooth bourbon!



- 2 ounces Bourbon
 2 ounces Pear Nectar or Juice
- ½ Lemon juice
- 1 ounce Ginger Honey Simple Syrup
 - Ginger Ale , to taste Ginger Honey Simple
- Ginger Honey Simple Syrup: (enough for 2 cocktails)
 - ¼ Cup Honey ¼ Cup Water
- 1 1" piece of Ginger peeled and thinly sliced
- Make the simple syrup: In a small saucepot combine honey, water and ginger. Bring to a gentle simmer over medium heat, stirring, until honey dissolves into water. Remove from heat and set aside to steep for 20 minutes. Strain into a container, discarding ginger, cover and refrigerate until ready to use.
- For the cocktail: Combine bourbon, pear juice, lemon and simple syrup in a cocktail shaker with ice. Vigorously shake until chilled.
 - Pour over ice in glass and top with a bit of ginger ale. Garnish with pear slices, a lemon wedge and a few pieces of crystallized ginger on a skewer.
